AYURVEDIC TREATMENT OF LIVER CIRRHOSIS AT PLANET AYURVEDA

ABSTRACT

Liver Cirrhosis is a condition in which there is a scarring or fibrosis in the Liver due to long term damage of the Hepatocytes or Liver Cells. In Ayurveda, Liver Cirrhosis is an effectively manageable condition, which is considered as challenging according to Modern Medical Science. In Ayurveda the major target is on Pitta Elimination which is carried out by a specific method which is known as Virechana or Medicated Purgation. This article is about the patient diagnosed with Liver Cirrhosis and treated with Ayurvedic Medications at Planet Ayurveda by keeping Virechana Therapy as the main line of treatment. A pure Ayurvedic treatment is given to the patient and in her Fibroscan reports it has been noticed that with the treatment given to her by Planet Ayurveda, the Fibroscan comes back normal. This is a review of the Non-alcoholic Liver Cirrhosis case of a 54 years old female who followed a particular diet chart and Ayurvedic Treatment provided by Planet Ayurveda.

INTRODUCTION

The term Cirrhosis is derived from the Greek word Kirrhos, which means "of yellow colour" and it is similar to the term sclerosis. The word Cirrhosis is commonly used which literally means Scarring or Sclerosis. There is no single definition or classification for cirrhosis vet that is suitable or satisfactory for all clinicians or pathologists.^[1] Liver Cirrhosis and Chronic Hepatitis are considered as two main interventions of Chronic Parenchymal Liver Disease and both are related closely because some conditions of Chronic Hepatitis may progress to Liver Cirrhosis.^[2] Liver Cirrhosis can occur at any age and often leads to prolonged illness. It is one of the important factors that can lead to death and manifests itself majorly in younger adults. Clinical features include Fatigue, weight loss, weakness, muscle cramps, non-specific digestive issues like nausea, anorexia, vomiting, gas, abdominal distention, etc. Associated conditions include Hepatomegaly, Jaundice, Ascites, Portal Hypertension, Hepatic Encephalopathy, etc.^[3] Investigations that are usually important for Liver Cirrhosis diagnosing include Plasma Transaminase, Plasma Alkaline Phosphatase, Plasma Bilirubin, Plasma Albumin. Imaging tests are required to analyse complications such as Liver Biopsy.^[4] If we talk about treatment of Liver Cirrhosis in Modern Medical System, they directly say there is no treatment that can reverse Liver Cirrhosis, treatment can just improve the


general health of the patient and manage symptoms only and can prevent complications.^[5]

Traditional system of Medicine is working hard to give people a healthy living. This mission is also started by Planet Ayurveda from the year 1999 with the Aim of Har Ghar Ayurveda - To make Ayurveda reach over the whole Planet. With this Aim of Dr. Vikram Chauhan we started this organisation from a very small surface but now we - A Planet Ayurveda family serving people worldwide in different countries of this Planet Earth. If we talk about Liver Cirrhosis it's a challenging situation for Modern Medicine but for the Ayurvedic Medical System it's miraculously manageable. Ayurveda is such a science which proves this wrong and for that we have an example about which we are going to mention in this study - A Case Study of the patient treated at Planet Ayurveda with Ayurvedic Medications. In Ayurveda there is no such direct correlation of Liver Cirrhosis and can be taken under Udara Roga (Abdominal Disorders) includes various conditions explained in Ayurveda, let's discuss those terms. The first condition which is connected with Liver Cirrhosis as per Ayurveda is Kamala which is commonly known as Jaundice. The cause of Kamala (Jaundice) is said to be that if a person who is suffering from Anaemia, consumes more Pittai Diet and follows a lifestyle that may aggravate Pitta Dosha.^[6] Diet and lifestyle that may aggravate Pitta

Dosha includes citrus fruits, onion, garlic, ginger, tomato, pulses such as kidney beans, black gram, soyabean, animal products, too much non-veg, Alcohol, wines, coffee, palm oil, packaged and processed food items, excessive anger, spending too much time in sun, etc. The second condition that is associated with Liver Cirrhosis is Kumbha Kamala; it is the chronic stage of Kamala (Jaundice). If there is no proper treatment given or delayed treatment given in case of kamala (Jaundice) it leads to chronicity.^[7] The third condition related with ayurveda is Liver Cirrhosis in Yakritodara (Hepatomegaly), in this condition the Liver becomes enlarged.^[8] Line of treatment for Liver Cirrhosis is to be done same as that of the treatment of Anaemia and Jaundice which is considered as Medicated Purgation (Virechana) with bitter and mild purgative herbs.^[9] By keeping this in mind Planet Ayurveda is treating patients worldwide and getting positive results too.

Pathophysiology of Liver Cirrhosis as per Modern Science and Ayurveda Pathophysiology Modern Aspect

Cirrhosis is followed by Fatty Liver and Hepatitis, what actually happens in Cirrhosis, the scar tissue replaces the normal parenchyma. There is a specific role of Stellate Cell in development of cirrhosis, which usually stores Vitamin A. When the Hepatic Parenchyma damage due to inflammation of hepatic cells, this process activate the stellate cells and obstructs the blood flow and increase the fibrosis. Chronic injury leads to inflammation, necrosis and then fibrosis. This whole process mainly involves activation of Stellate cells, kupffer cells and damaged hepatocytes, other than that activated platelets are also involved.^[10] Brief View is shown in the flow chart.



Ayurvedic Aspect

Pathophysiology of Liver Cirrhosis as per Ayurveda is considered to be same as the Pathophysiology of Udara Roga (Abdominal Diseases). The two main reasons for Udara Roga (Abdominal Diseases) are Agni Dosha (Defective Digestive Strength) and Mala Vriddhi (Increase in morbid matter or waste product). If the Agni (Digestive Fire) is low and a person intake viruddha ahara (incompatible food), leads to indigestion and after that the Doshas get accumulated. This further leads to vitiation of Prana Vayu, Apana Vayu and Agni and obstruction of channels of circulation. Here Prana Vayu is one of the forms of Vata Dosha which is considered as Vital Force, Apana Vayu is another form of Vata Dosha which is responsible for elimination of wastes such as urine, faecal matter, etc from the lower part of the body. After that vitiated doshas get lodged between the muscle tissue and skin causing distention of the lower part of the abdomen and give rise to various abdominal diseases including Liver Cirrhosis associated with Ascites.^[11]



MATERIALS AND METHODS

Case Study of a Patient: A 54 years old, female patient visited Planet Ayurveda's OPD for the first time on 6th December, 2022. At that time she was diagnosed with Liver Cirrhosis and at that time she brought a Fibroscan report dated 21st October, 2022, showing CAP value 360 dB/m and E value 15.4 kPa. After taking treatment for almost 1 year and following a proper diet chart provided to her, the Fibroscan reports came back to normal showing CAP value 250 dB/m and E value 7.7 kPa. From here it reflects that Ayurveda can do impossible things possible and this is the beauty of Ayurveda in the field of Health.

RESULTS

Main Results that were noticed are in the Fibroscan report that is the normal E and CAP values. CAP value reduced from 360 dB/m to 250 dB/m and E value reduced from 15.4 kPa to 7.7 kPa.

So this is beneficial in relieving symptoms associated with Liver Disease such as Constipation, Indigestion, Abdominal Distention, Abdominal Pain, etc.^[15]
